# Fund description and summary of investment policy

The Fund invests in a mix of shares, bonds, property, commodities and cash. The Fund can invest a maximum of 45% offshore. The Fund typically invests the bulk of its foreign allowance in a mix of funds managed by Orbis Investment Management Limited, our offshore investment partner. The maximum net equity exposure of the Fund is 40%. The Fund's net equity exposure may be reduced from time to time using exchange-traded derivative contracts on stock market indices. The Fund is managed to comply with the investment limits governing retirement funds. Returns are likely to be less volatile than those of an equity-only fund or a balanced fund.

# Fund objective and benchmark

The Fund aims to provide a high degree of capital stability and to minimise the risk of loss over any two-year period, while producing long-term returns that are superior to bank deposits. The Fund's benchmark is the daily interest rate as supplied by FirstRand Bank Limited plus 2%.

# How we aim to achieve the Fund's objective

A major portion of the Fund is typically invested in money market instruments. We seek to deploy the Fund's cash by investing in shares when they can be bought at a significant discount to their intrinsic value. We thoroughly research companies to assess their intrinsic value from a longterm perspective. This long-term perspective enables us to buy shares which are shunned by the stock market because of their unexciting or poor short-term prospects, but which are relatively attractively priced if one looks to the long term. If the stock market offers few attractive shares, we may allocate a low weight to shares or partially hedge the Fund's stock market exposure in consideration of the Fund's capital preservation objectives. The Fund may also invest in bonds, property and commodities. The Fund's bond and money market investments are actively managed.

### Suitable for those investors who

- Are risk-averse and require a high degree of capital stability
- Seek both above-inflation returns over the long term, and capital preservation over anv two-vear period
- Require some income but also some capital growth
- Wish to invest in a unit trust that complies with retirement fund investment limits .

## Meeting the Fund objective

## Annual management fee

Allan Gray charges a fee based on the net asset value of the Fund excluding the portion invested in Orbis funds. The fee rate is calculated daily by comparing the Fund's total performance over the last two years, to that of the benchmark. If the Fund's return over two years is equal to or less than 0%, Allan Gray will not charge a fee.

### Fee for performance equal to the Fund's benchmark: 0.80% p.a. excl. VAT

For each percentage of two-year performance above or below the benchmark, we add or deduct 0.1%, subject to the following limits:

Maximum fee: 1.30% p.a. excl. VAT Minimum fee: 0.30% p.a. excl. VAT

This means that Allan Gray shares in approximately 20% of annualised performance relative to the benchmark.

A portion of the Fund may be invested in Orbis funds. Orbis charges performance-based fees within these funds that are calculated based on each Orbis fund's performance relative to its own benchmark. Orbis pays a marketing and distribution fee to Allan Gray.

# Total expense ratio (TER) and transaction costs

The annual management fees charged by both Allan Gray and Orbis are included in the TER. The TER is a measure of the actual expenses incurred by the Fund over a one and three-year period (annualised). Since Fund returns are quoted after deduction of these expenses, the TER should not be deducted from the published returns (refer to page 4 for further information). Transaction costs are disclosed separately.

The themes we have discussed in previous commentaries continued to dominate the news flow in the second quarter of 2023. While globally, headline inflation data looks to have peaked, the core components of the basket, such as services and wages, are proving stickier than previously anticipated. Market expectations of interest rate cuts, now anticipated for later this year, run contrary to recent central bank actions and the prevailing hawkish rhetoric. Real interest rates (i.e. inflationadjusted) in developed markets outside of the United States remain in negative territory. If inflation is to abate closer to target levels sustainably, more restrictive rates may be required and/or a slowing economy that reduces aggregate demand – which would be a challenging scenario for risk assets. The recent strong performance of global equities, however, and particularly the long-duration technology stocks, suggests that markets are pricing in a low probability of this scenario materialising.

The pace of the reopening of the Chinese economy after last year's lockdowns continues to underwhelm, with previously implemented large-scale stimulus measures conspicuous by their absence. The stability of the housing market remains a concern and introducing further stimulus into an already over-leveraged sector may exacerbate the underlying issues. A change in focus from strong economic growth to one of greater self-reliance owing to wider geopolitical shifts is also relevant. Commodity prices, important for South Africa's fortunes, are softer year to date in response to the weaker-than-expected Chinese demand, together with broader global growth concerns.

As if the backdrop was not challenging enough, own goals on the part of our government continue to depress sentiment and local asset class returns, despite the low starting valuations. High levels of loadshedding, ongoing logistical constraints and worsening service delivery, as well as the disclosure of possible arms sales to Russia – contrary to our "non-aligned" status and what that might lead to – have meant a repricing of South African sovereign risk. While they partially recovered, government bond yields sold off to near COVID-19 crisis levels and the rand has depreciated 10.7% against the US dollar year to date. This has knock-on consequences for monetary policy given concerns around the attractiveness of the rand and the ability to continue to attract foreign capital, in addition to the pass-through inflation effects from a weaker currency.

The Fund has returned 6.2% year to date, 1.9% ahead of the benchmark. Foreign assets have been the main contributor, providing a valuable diversification benefit given the weaker performance of local asset classes. The largest change in asset allocation during the quarter was an increase in allocation to local cash owing to the attractive level of real returns on offer. The net equity weight of 25.5% (relative to the allowed maximum of 40%) together with a healthy allocation to hedged equities reflects the more cautious stance given the uncertain environment.

During the quarter, the Fund added to existing positions in AB InBev, MultiChoice and Woolworths while trimming its exposure to precious metal and diversified miners, and reducing its stake in Prosus.

#### Management Company

Allan Gray Unit Trust Management (RF) (Pty) Ltd (the "Management Company") is registered as a management company under the Collective Investment Schemes Control Act 45 of 2002, in terms of which it operates unit trust portfolios under the Allan Gray Unit Trust Scheme, and is supervised by the Financial Sector Conduct Authority (FSCA). #### Performance

### Fund mandate

### Unit price

Unit trust prices are calculated on a net asset value basis, which is the total market value of all assets in the Fund, including any income accruals and less any permissible deductions from the Fund, divided by the number of units in issue. Forward pricing is used and fund valuations take place at approximately 16:00 each business day. Purchase and redemption requests must be received by the Management Company by 14:00 each business day to receive that day's price. Unit trust prices are available daily on www.allangray.co.za.

### Fees

Permissible deductions may include management fees, brokerage, securities transfer tax, auditor's fees, bank charges and trustee fees. A schedule of fees, charges and maximum commissions is available on request from Allan Gray.

### Total expense ratio (TER) and transaction costs

The total expense ratio (TER) is the annualised percentage of the Fund's average assets under management that has been used to pay the Fund's actual expenses over the past one- and threeyear periods. The TER includes the annual management fees that have been charged (both the fee at benchmark and any performance component charged), VAT and other expenses like audit and trustee fees. Transaction costs (including brokerage, securities transfer tax, Share Transactions Totally Electronic (STRATE) and FSCA Investor Protection Levy and VAT thereon) are shown separately. Transaction costs are necessary costs in administering the Fund and impact Fund returns. They should not be considered in isolation as returns may be impacted by many other factors over time, including market returns, the type of financial product, the investment decisions of the investment manager, and the TER. Since Fund returns are quoted after the deduction of these expenses, the TER and transaction costs should not be deducted again from published returns. As unit trust expenses vary, the current TER cannot be used as an indication of future TERs. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. Instead, when investing, the investment objective of the Fund should be aligned with the investor's objective and compared against the performance of the Fund. The TER and other funds' TERs should then be used to evaluate whether the Fund performance offers value for money. The sum of the TER and transaction costs is shown as the total investment charge (TIC).

### **Compliance with Regulation 28**

The Fund is managed to comply with Regulation 28 of the Pension Funds Act 24 of 1956 (the "Pension Funds Act"). Exposures in excess of the limits will be corrected immediately, except where due to a change in the fair value or characteristic of an asset, e.g. market value fluctuations, in which case they will be corrected within the prescribed regulatory time period. The Management Company does not monitor compliance by retirement funds with section 19(4) of the Pension Funds Act (item 6 of Table 1 to Regulation 28).
